- “Election Assembly – November 20-22, 2015 – Rogelio R, D53 – Assembly is at Fresno Fairgrounds. Nancy will meet with committee members on November 1 for final details. We continue to receive registrations. We're going to groups outside Fresno. We hope to have large attendance from all Spanish-speaking groups.” There were also reports from the Winter Assembly for January 16<sup>th</sup> and 17<sup>th</sup> in District 11, Pre-Conference Assembly for April 9<sup>th</sup> and 10<sup>th</sup> in District 40, and Post-Conference Assembly for May 21<sup>th</sup> and 22<sup>nd</sup> in District 09.
- From Tom A – Area Treasurer. “A of our financial obligations have been paid when received. We have a healthy checking account balance and a full prudent Reserve. The 2016 Proposed Spending Plan will be available for discussion at the ACM ...on schedule for an ACM recommendation and final proposal to introduced at the Election Assembly for approval from the Assembly body.” Note, Judy B – Finance Chair. Line item #7682, from Alt- Chair was change from \$250 to \$450.
- Ad Hoc Committee on DCM travel to ACM – The proposal has been altered to help DCMs get to ACM from 6 8 meeting for those who need it.
- The “One Day Assemblies” proposal will be discussed at Election Assembly.
